The headline from Reuters, Oct. 5, 2015 reads: “Pope says Church can’t be ‘museum’, but be open to change.” The specifics of that change are creating some strong sentiments on both sides of the issue, and it seems that since October the debates have heated up. This article is not about the issues embroiling the papacy of the Roman church. Yet, the wording of the headline serves as an illustration to what this article does seek to address.

In every generation there are those who see the rules of the church, which Jesus built (Mt. 16:18) and purchased with His precious blood (Acts 20:28; 1 Pt. 1:19; Rev. 5:9), as archaic. They see the church as little more than a living museum. They believe passionately and sincerely that a change to make it more relevant to the modern cultural and communicative norms would be positive and therefore necessary.

Buried deep within the layers of efforts to change things out of a desire to modernize and create or, at the least, enhance relevancy lies a fundamental axiom that is almost never detected until the changes clamored for require its emergence.

Changing anything about what belongs to someone else demands a change in ownership.

This is not the same thing as perceiving a need for someone to change their business policy or their house rules and then presenting that person with the reasons for needing change in a way that convinces the owner such a change is necessary. It is his to begin with, and it remains his throughout the process. He sees the need to change and he wills that change, and therefore his ownership is never relinquished.

But when someone other than the owner perceives a change, develops an argument to promote that change, wins support from others to demand the change—and then effects the change without the owner’s consent, a change of ownership has occurred!

Some who demand change are naïve, never thinking or intending to take ownership of what was never theirs in the first place. They simply believe strongly that their perceived needs for change override all else. Others are more aware of the principles at stake and make their insistent demands for change in arrogant expectation of ownership. They know what they are doing and are intentional about it.

The Lord’s church is not only bought and paid for, therefore owned, by Jesus the Christ; the Lord’s church is set up according to His will. Men cannot change one thing that is given in Scripture by commands, by examples, or by necessary inferences without taking ownership. There is no middle ground on this. If we force change by our teaching and our practice, we necessarily take ownership.

Now what does ownership demand? RESPONSIBILITY! Those who embrace the changes in teaching and the changes in practice that they were taught are not in the Lord’s church. They never were. They are in the church of the person who effected those changes. That new owner is now responsible for their souls. They, unwittingly in most cases, entrusted their souls to the teachings of the new owner. But the new owner can’t forgive because he cannot redeem them with his sinless and precious blood. The new owner can’t grant them eternal fellowship in heaven because he hasn’t gone to heaven to prepare a place for them (Jn. 14:3). The new owner can’t change their circumstances when they commit future sins because he is not their advocate before the throne of God (1 Jn. 2:1,2).

If you take over my business, you own it. You now have to see to and administer its every detail. Whether you wanted to or not, whether you have time to or not, you must! Its success or failure is now yours. Think long and hard about taking from another man because you think you know a better way. And think even more soberly about changing what belongs to the Lord no matter how convinced you may be that a change is needed. Ask yourself this question: Can you live up to the responsibility?

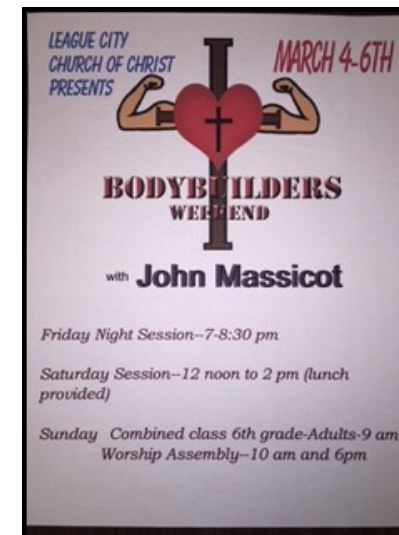
